# No More Groundhog Day?

- While during the 112<sup>th</sup> Congress, the House repeatedly (30+ times) sought to cut or eliminate the Prevention Fund...
- Post election – Speaker Boehner said “Obamacare is the law of the land.”
- Of course, hours later... “Speaker Boehner and House Republicans remain committed to repealing the law” and there’s talk of modifying the law piece by piece.
- And then via Tweet – “Obamacare is the law of the land, but it is raising costs & threatening jobs. Our goal has been, and will remain, full repeal.”
- Post-election Kaiser Family Foundation tracking poll finds just 1/3 of Americans support repeal of ACA, the lowest since becoming law in March 2010, and for the first time, a small majority (43-39) in support.
- On November 12<sup>th</sup>, the American Medical Association House of Delegates approved a resolution “opposing policies that aim to cut, divert, or use as an offset, dollars from the Prevention and Public Health Fund for purposes other than those stipulated in the Affordable Care Act of 2010.”

# Champion development in full gear

- Over the summer, TFAH, American Heart Association, American Cancer Association Action Network, American Diabetes Association, ASTHO, NACCHO, American Public Health Association, Nemours, Campaign for Tobacco Free Kids, National Business Coalition on Health met with numerous members of Congress, including Senators Brown (OH), Blumenthal (CT), Cardin (MD), Carper (DE), Coons (DE), Hagan (NC), Rockefeller (WV), Menendez (NJ), Bennet (CO) and Udall (CO), and Representatives Capps (CA), Delauro (CT), Roybal-Allard (CA), Pallone (PA), Van Hollen (MD), Matsui (CA) and Levin (MI)
- A number of the Senators are following through with more than ½ dozen “dear colleague” letters in November and December addressing support for the Prevention Fund by addressing multiple issues such as obesity, diabetes, tobacco use, women, seniors, rural issues and children/youth.
- Representatives Capps, Matsui, and Roybal-Allard are circulating a draft California delegation letter to the White House in support of the Prevention and Public Health Fund.

# What can you do?

- Show members of Congress where the money is going – need for transparency on use of funding, and relationship-building by grantees with elected officials
  - Create relationships with elected officials
  - Give visibility to success stories in local media
